#### About the review

The proposed changes by the university follow a review of the BA(Hons) Social Work against a change to the regulatory landscape, reflecting the introduction of Social Work England's professional standards and education and training standards 2019.

In addition, the course has been reviewed against the introduction of the university's 'Real World Curriculum Framework' to ensure that the course reflects the university's approach to teaching, mission, ethos and strategic objectives. The university has provided evidence in support of this change request which has been reviewed by the allocated inspectors.



## **Findings**

The inspectors have reviewed the documentary evidence and consider;

- There is a clear rationale for the change which arose from the requirement of the
  course team to align the course to Social Work England's standards alongside the
  introduction of the university's 'Real World Curriculum Framework'. The course team
  also took the opportunity to provide information about improvements they have made
  to aspects of practice based learning, for example revising the training and support
  available to practice educators.
- The course was mapped against a number of standards and documentary evidence was provided in several areas, with an overview of how the course had previously met the standards and the proposed changes. This reflected the many minor changes which had arisen as a result of the dual reviews, including the revision of course documentation such as student handbooks, module descriptors, policies, assessment strategies and the course specification. For example, updating the Fitness to Practice Policy and Student Disciplinary Procedure with reference to Social Work England's professional standards.
- Inspectors felt that the alignment of the course with the themes within the university's 'Real World Curriculum Framework' fitted well with the ethos and aims of a social work education, and therefore there was strong alignment between the university's wider objectives and the ability of students to meet Social Work England's professional standards. For example, a focus on ensuring that students can apply theory to practice, develop research skills, foster a commitment to life-long learning and value learning for its own sake.
- With regards to admissions inspectors noted that the course has revised applicant and student facing documentation to reflect the new regulatory landscape. There has also been an increase in the IELTS minimum requirement, to an overall score of 7.0.
- Documentary evidence was provided of ongoing efforts to manage the capacity and availability of practice-based learning in the region, including the course team's involvement in the Social Work Education Network and the establishment of a Practice Learning Coordinator's Forum. Inspectors felt that from the evidence provided there seemed to be strong links with local employers. Likewise, evidence was provided which demonstrated the course team's ongoing engagement with practice educators to ensure that they have access to training and support.
- Inspectors noted that with regards to practice based learning the proposed changes included an increase in the number of skills days from 12 to 30. The documentary evidence indicated that that the provision of additional skills days would support students to prepare for their practice based learning.



- Inspectors were able to review documentation detailing assessment methods, learning
  outcomes and module descriptors which had been mapped against and revised to
  reflect the standards. It was felt that the overall assessment strategy and design was
  appropriate for a social work course and would enable the students to meet Social
  Work England's professional standards.
- Overall, the changes reviewed by the inspectors were considered to be positive. The
  documentary evidence provided demonstrated that the course team are seeking to
  enhance provision, meet the required standards and ensure that the course is kept upto-date.



## Conclusions

The inspectors are recommending approval.
