#### About the review

The proposed change by the university is an increase from a maximum student intake of 40 students to 50 students. This is to accommodate the transfer of students onto the course, at level 5 and level 6, who are not able to continue their studies with another social work education provider. The university has provided evidence in support of this change request which has been reviewed by the allocated inspectors.



## **Findings**

The inspectors have reviewed the documentary evidence and consider;

- There is a clear rationale for the change which arose from extraordinary circumstances, as the students transferring to the University of West London were not able to continue their studies with their prior social work education provider. The transition included joint meetings and conversations between Social Work England, the University of West London, The Office for Students and the student's prior education provider.
- Inspectors were provided with an overview of the information provided to and
  engagement undertaken with transferring students by the course team, to enable
  students to make an informed choice about whether to continue their studies with the
  University of West London. This included meetings with students. Inspectors were also
  able to review induction materials, in addition to the university's policy and guidance
  for students on the recognition of prior learning.
- The University of West London provided documentary evidence that they have established a new working relationship with Oxford City Council and Activate Learning, in order to provide practice-based learning opportunities for students based in Oxford. Steps have also been taken to engage with, and provide training to, new placement providers and practice educators on the university's policies and processes. The inspectors are recommending that this engagement and support continues to ensure that new partners have the information and resources available to support the wellbeing and learning needs of the transferring students, throughout their practice-based learning.
- Inspectors were able to review documentation that outlined the appointment of a new member academic staff to support the transferring students. This will include supporting teaching and learning, in addition to pastoral support and liaison with placement providers based in Oxford. For the first few months this will be a part-time, hourly paid role, but the education provider has indicated that the position will become permanent from January 2021.



#### **Conclusions**

The inspectors are recommending approval, with a recommendation against standard 3.13 'There will be effective and accessible arrangements in place to support the wellbeing and learning needs of students in all settings'.

This recommendation reflects that the transferring students may require additional, ongoing support to ensure that they integrate into the new education environment and adapt to new policies, procedures and structures.

Furthermore, as the University of West London establishes new relationships with placement providers in the Oxfordshire region, these providers will require support to ensure that they are able to provide a quality practice-based learning experience, including information and guidance to practice educators and students.
